Basic Information Sheet — South Carolina's Road Team

In 1997 the South Carolina Trucking Association's Board of Directors approved the creation of a South Carolina Road Team.

The mission of the South Carolina Road Team is to enhance the professional standing of the truck driver, promote recognition and appreciation of the contributions trucking makes to our economy and our quality of life and to make highways safer by placing the best professional truck drivers available before any group of interested citizens to discuss matters of sharing the road.

SCTA is searching for qualified professional drivers, both men and women, who are willing to take time away from the cab of their truck to tell the story of the trucking industry. As an official Road Team representative, these drivers may speak approximately four times each month, for a 18-month term, before media, schools, businesses and civic groups to demonstrate the trucking industry's commitment to safety and professionalism.

Eligibility

1. Nominees must be currently employed as a full-time truck driver, either as company drivers or independent owner-operators.
2. Nominees must have an outstanding safety record. They also must maintain a record that includes no preventable accidents or ticketed violations in both the truck and personal vehicle for the previous three years.
3. Nominees must be able to clearly and convincingly communicate their commitment to safety and courtesy. They must also be able to present a positive, professional image.
4. The nominee, if selected must be willing to appear up to four times each month during their term traveling and speaking on behalf of the industry.
5. The nominating company must be a full dues paying member of SCTA.
6. The "nominator" must be either a motor carrier executive with the authority to commit his company's support for the program or a self-sponsored owner-operator. The nominator should also confirm — before making application — that the candidate is willing to participate in the program.
7. South Carolina Road Team will pay expenses (hotel, personal mileage and meals) associated with Road Team appearances that are not covered by the employees company. The nominating company must be willing to continue to pay salary and provide benefits to the driver while he/she is traveling for SCTA and specifically when they are not driving a company vehicle or do not have a sleeper berth. In the case of an Owner-Operator, the company must be willing to pay the driver an agreed upon per diem for each event spent traveling for SCTA.
8. An independent owner-operator who is a dues paying member of SCTA may act as both nominating company and candidate. SCTA will pay travel costs, but will not be responsible for compensating a self-sponsored owner-operator for lost revenue while traveling for the SC Road Team. In selecting the representative, emphasis will be placed on the driver's safety record and ability to speak knowledgeably about the trucking industry.

Procedure

To nominate a driver, please complete the Nomination Form and return it with a current professional photo to: SCTA c/o SC Road Team, PO Box 50166, Columbia, SC 29250-0166.

After the individual has been nominated, it is the nominator's responsibility to immediately notify SCTA if the candidate becomes ineligible at anytime during the selection process.

Once the nomination process is closed, SCTA will announce a small group of finalists who will come to Columbia for personal interviews. At that time, a panel of industry and public relations professionals will select the South Carolina's Road Team.
